

The Bureau of Gambling Control (Bureau) reserves the right to: (1) review the lawfulness of any nonprofit fundraising activity; (2) notify all law enforcement agencies if further review determines the nonprofit fundraising activity to be unlawful; (3) require nonprofit organizations to cease and desist offering for play or conducting any nonprofit fundraising activity, if found to be unlawful; and (4) take action against those nonprofit organizations that decline to abide by the Bureau's cease and desist notification.

This registration may be revoked by the Bureau if, in the opinion of the Bureau and/or the local law enforcement agency, it is necessary to protect the safety, welfare, and health of the people of the State.

**Re: Supplier Annual Registration Approval**

The Bureau of Gambling Control (Bureau) has reviewed the supplier annual registration form and determined that your organization meets the criteria to provide "controlled games" as identified in California Penal Code section 337j. Bam Casino Party Rentals has been approved only to supply controlled games and services that are played as a fundraising mechanism. Your registration will no longer be valid after December 31, 2024 or when your local business license expires on December 31, 2024 - whichever comes first.

If your business license expires prior to December 31, 2024, you will need to submit a copy of your renewed local business license showing your updated business license expiration date in order for your business name to stay on the Bureau's webpage as a registered supplier after the expiration of your previously submitted local business license. Upon receipt of a copy of your renewed local business license, we will issue you a new approval letter with an updated expiration date. You will not need to pay another \$100 fee until the next calendar year in which you register.

The registration program for suppliers of gambling equipment and/or services are for supplies associated with "controlled games" only. Games played with dice are not authorized for play by Penal Code section 337j nor approved by the Department of Justice as controlled games. Games such as roulette, twenty-one, banking or percentage games, and dice games, when offered for play for anything of value, are prohibited by Penal Code section 330 and 330b. These games are prohibited as they are not "controlled games," and therefore cannot lawfully be offered at nonprofit fundraising events. Even if not played for anything of value, games such as roulette, twenty-one, banking or percentage games, and dice games are not "controlled games" within the meaning of the nonprofit organization controlled games fundraiser statute (Bus. & Prof. Code, §§ 19885-19887). Nonprofit organizations are therefore precluded from playing those games at fundraisers because they cannot be approved as "controlled games." The Bureau will not register a nonprofit fundraiser or a supplier that offers prohibited games or gambling-themed games outside of the scope of the nonprofit organization controlled games fundraiser statute.

Please keep in mind that any game offered by you beyond those approved by the Department of Justice is not a "controlled game." Should you provide to nonprofit organizations for fundraiser events a game or games not approved by the Department of Justice, you do so at your own risk and not under the approval of the Bureau. The Department of Justice reserves any and all rights to take appropriate action against illegal gambling activities. In addition, slot machines may not be offered for play and are prohibited by Penal Code sections 330.1, 330a and 330b.
